## Minutes of Goathurst Annual Parish Council Meeting Monday 16 November 2020 @ 7.30pm, Remote meeting hosted by 'Zoom'

Matters arising and action points not covered on agenda: Update from Cllr Mike Caswell with regards to Lovedere traffic as discussed in meeting 14 September 2020: Increased traffic and size of vehicles is problem for most rural communities, and unless concerted effort there will continue to be issues around damage to roads and verges, and verge environment. Cllr Caswell has a meeting arranged, delayed due to Covid-19 and will keep Parish Council informed. Noted that new concrete base has gone down on Lovedere, however there have been no planning applications so assumption that not for additional building.

12. **The 'Telephone Exchange':** Ongoing — weather dependent, will probably roll into spring now.

- 13. **Lych Gate**: Richard not heard anymore from PCC to chase again. Clerk to confirm with Richard/Clerk works company on validity of quote and availability.
- 14. Somerset Action in Villages for the Environment and Climate (SAVE Climate): Steve Howell, Secretary from EcoCentre joined the meeting. Project was registered last year with the aim to promote sustainable living and working. Has two strands EcoCentre, which due to Covid has been delayed, and an Outreach Program, with a mobile unit and worker to support the community.

Looking to make a group application from parish councils (with no cost to parishes) to access the County Councils Emergency Community Fund. The fund would be used for a mobile unit (bus or van), powered by green/sustainable fuel, an outreach project worker and the running costs for one year. After the first year, EcoCentre will take over the running costs for the project. Unit will be kitted out with interactive displays for community events, and help communities take action on climate change by providing advice and information. Will also work with local community 'Green' groups to support though training,

The grant application is £50,000, possibly more depending on number of councils which join. Mobile unit is novel, there are other ecocentres in UK, but these are more limited in their scope.

Richard set a motion to support, seconded by John Capell, and it was noted that Danielle in favour.

The application will be undertaken by Somerset Co-operative Services on the group of councils' behalf, final submission will be late December, Steve Howell and Richard to liase as necessary. Clerk to send Steve contact details.
